

## C.E.T.A. GENERAL MEMBERSHIP MEETING

A bid was received for lawn mowing from Allen Miler for \$35.00 for each mow. Moved by Nancy and seconded by Dianne to accept the bid, also buy a billing book.

Sandy turned in 5467 sales slips to Northland. Each receipt has points and Sandy receives a check from Northland.

We discussed the newsletter. We need to change some dates. Harvest dinner will be September 30, from 11:30 a.m. until 4:00 p.m..

Joyce, had no membership report, it is the same as last month.

Dianne nominated Don Magyar to be in charge of advertising. Passed.

Marge B will chair the harvest dinner. Price for adults will be \$7.00, children's ages five to twelve will be \$3.00. Children less than five will be free. - Menu for dinner stuffed cabbage and boiled potatoes.

The ceiling in foyer needs to be replaced.

Dianne needs \$200.00 for four licenses. Bob and Doris will be in charge of the kitchen.

A suggestion was to ask clergy about advertising in bulletins about Harvest dinner.
