## NEW BOARD MEMBERS

During this past year, we have had 2 new Board members.

Margo Casto resigned as Treasurer, and the board appointed **BRENDA LAMBERT** to fill her position until the next general election.

Dino Paladino resigned as Trustee, and the board appointed **DENNY CORRADO** to fill his position until the next general election.

## **TRASH REMOVAL**

Again this year we have contracted to have 4 large-item pickups along with our regular trash removal days (Mondays). We have provided 4 labels (numbered 1-4) to each taxpayer with this newsletter. Please remember that **PRIOR** to placing an item out for pickup, it is requested that you contact **AMERICAN WASTE** at the number on the label to advise them of what you are placing out for pickup and where the pickup is located. In some instances, large items may not necessarily be picked up on normal trash day. However, if called prior to our normal pickup day of Monday, large items will be removed within a day or two of our normal pickup day.

If you have more than 4 large items that you need to dispose of, or are "cleaning up" and need to dispose of items in quantity, Kankaska County operates a trash recycling facility located at the Island Lake Road facility. You can contact the Island Lake Road facility at 258-3369 to find out their operating hours (it varies by season), and what items they will or will not accept.

**AMERICAN WASTE DOES NOT** pick up trash on any private roads. Residents/property owners on private roads are required to leave their trash for pick-up **no earlier than Sunday afternoon** at the intersection of their private road and the county-maintained road intersecting it. Each township property owner is allowed five 30 gallon bags for pickup each week. On weeks that have a holiday on the regular Monday pick-up day, trash will be picked up on Tuesday instead. Questions concerning missed pickups should first be directed to **AMERICAN WASTE AT 258-9030**. If they are unable to provide you with a satisfactory response, do not hesitate to call one of your township board members at the numbers listed on the first page of this newsletter.

Trash will NOT be collected on Memorial Day (May 26<sup>th</sup>) or Labor Day (September 1<sup>st</sup>), but will be collected the day following. Please note on your calendar.

## **ROAD ENDINGS/ACCESS**

We ask that those of you who use the road ending at the foot of Ford Road to take care not to block access to the water hydrant. It is imperative that our fire department have clear access to the hydrant in order to replenish the pumper truck with water when fighting fires in the area. We have placed "No Parking Zone" signs around the hydrant, and will enforce them by having any vehicles blocking them towed to the county impound lot.

As always, those of you who use the road endings in the summer or winter are asked to be courteous to the property owners on either side of the road endings - do not trespass on their property, and do not use their docks. Please respect their property as you would your own!

## **CEVFR**

The Coldsprings/Excelsior Volunteer Fire Department Board of Directors meet the first Wednesday of each month at 7:00pm at the Fire Hall located at 6617 Country Road 612 East. The public is invited and encouraged to attend these meetings.

CEVFR is always looking for individuals interested in becoming an active part of Fire and/or Rescue within the joint townships. If you are interested, or know of someone that may be interested in joining the Department, please let us know.

The Board and membership of CEVFR strongly urge the citizens of Coldsprings Township to favorably act on the renewal of the operating and equipment millage that is due for renewal during this year's elections. Your continued support is greatly appreciated!

## **MANISTEE LAKE IMPROVEMENT BOARD**

After completion of the public hearing process, the Manistee Lake Improvement Board voted to move forward and establish a special assessment district to address the concerns expressed by the citizens on Manistee Lake.

Introduction of 10,000 milfoil weevils has already occurred, and this spring there will be more planted. Surveys are still being conducted by Progressive AE Engineering, and we expect some noticeable improvements in the lake later this year.

Concerns have been raised about establishing a set lake level on Manistee Lake, but the Manistee Lake Improvement Board does not have the authority to accomplish this. However, we are planning on addressing this issue with the County Board of Commissioners, the DNR and DEQ to see about establishing a permanent level.

The MLIB has not set up a schedule of meeting dates for 2008, as they meet when necessary to move forward with new information. ## **TOWNSHIP ROAD IMPROVEMENTS**

Denny Corrado has been appointed as the Township's representative to the Kankaska County Road Commission meetings. We are STILL trying to ensure that our voice is heard at the Road Commission to address the concerns we have long had with Starvation Lake Road, along with the grading and plowing of secondary roads throughout the township.

The Township Board elected to move forward this past year with paying for the improvements on Starvation Lake out of the Township Improvement Fund. However, the quote of \$186,000 given to us the previous year had jumped to more than \$375,000 (without a really coherent reason), and we have yet to hear back from the Road Commissioner regarding that project. We WILL NOT accept that kind of increase!

We hope that you, as taxpayers, would make your interests and concerns known to the County Road Commission. Their phone number is (231) 258-2242.

The Board is also greatly concerned about the condition of County Road 571 after the US-131 construction

was completed. The road is now heaved and cracked, and the money allocated to the Road Commission from the State of Michigan only allows for a micro-coat of finish, which will not in the least address the problem. We have also addressed this concern to the Road Commission, and are still awaiting their reply.

## **COLDSPRINGS TOWNSHIP WEBSITE**

We are placing the approved minutes of each board meeting on this Website, along with minutes of the Board of Review. This Website can also access Excelsior Township information (under construction), the Coldsprings Excelsior Volunteer Fire and Rescue Department (CEVFR); and the Coldsprings Excelsior Taxpayers Association (CETA).

This Website is packed with lots of information, and if you are someone that has online capability, it would be worth your while to log onto it and discover some of the things that have been happening in your community.

Items of interest also include a calendar of events and copies of recently enacted township ordinances.

If you log into the Fire Department, a tremendous amount information can be obtained regarding equipment, procedures, run information, the Fire Explorers Post, and much, much more.

## **CELLULAR TOWER**

We are STILL trying to elicit some interest in a cellular tower in the township. Now that CR 571 is no longer the bypass route for the US-131 construction, the volume of traffic has decreased, and the cell companies are not getting as many "dropped call" complaints as they were last summer when they expressed interest in erecting a tower. We ask you to continue to make it known to your cell provider that we want service available in our township (it's not enough for just the Township Board to tell them). Stay tuned....

## **CEMETERY**

Last year, through a unanimous vote, the Board made a change to the Sexton's Manual that limits items placed on individual graves (other than new burials) to a maximum of two.

In the ongoing attempt to keep our township cemetery clean and serene, it requires that each headstone be weed-whacked regularly, and the time involved in moving numerous grave-site items is very costly. The township maintains the cemetery out of respect to those buried there, and their relatives and friends who come to pay their respects. We would appreciate it if the plot owners abide by the rules.

## **ELECTIONS**

The primary election will be held on August 5, 2008.

The General Presidential Election will be held on November 4, 2008.

## **PROPOSED POWER PLANT IN RAPID RIVER TOWNSHIP**

Please consider attending the March Rapid River Township meeting the third Tuesday of March (the 18<sup>th</sup>) at 8:00pm.

The township has invited Rock Management to address the township regarding the power plant they plan to build on the Alexander farm property. The property is 270 acres located South of Plum Valley and East of 131. The power plant would use renewable energy, wood chips, and be similar to the plants in Grayling, McBain and Cadillac. The township has planned that the presentation will be at 8:00 for only one hour and that there will be time for questions.

This will not be the only public meeting on this subject. There will be additional public meetings when the County Planning Commission considers the application.

The developer, Rock management is partnered with Jordan Exploration, a local company and also has a lien on an additional 150 acres North of Plum Valley Road and east of 131.

Kalkaska County does not have an ordinance allowing power plants as an allowed or special use so the developer has hired a planning company to present a model ordinance to the County Planning Commission. They have also agreed to place money in escrow for the County to hire a planner and legal staff so that an ordinance suitable to the County can be developed for consideration.

It is not uncommon for unusual uses to be excluded from county and municipal ordinances. Some common usages like welding were only recently considered as a use in Kalkaska County.

The developers have stated that it is their intention to construct and operate a wood fired power plant but also to solicit other businesses that can use their power, waste steam and heat to co-locate on the site.

***NEW EMAIL ADDRESS***

If you will note on the front page, the Township has a new email address. We now have high-speed service through Charter Communications.

***SEPTIC ORDINANCE***

On January 24<sup>th</sup>, the County water/septic inspection committee met in the Commission Chambers.

The Coldsprings Township Board and the Manistee Lake Improvement Board have requested a local ordinance in response to high bacterial counts and excessive weed growth in the lake. Septic tank seepage is suspected to be a factor in both.

The meeting addressed a suggested procedure for inspection of water front septic tanks at time of sale or transfer of the property in Coldsprings Township, Kalkaska County. The resulting ordinance

would be local to Coldsprings Township, and the township would have to both enact it and enforce it.

***DNR Offers New Web Site,  
Toll-Free Number for Public to  
Obtain Burn Permits***

Michigan citizens can now access burn permits online for rakings and vegetation burning while doing spring or fall cleanup work on their property. The Department of Natural Resources recently received a federal grant to make burn permits more easily obtainable for property owners in the northern Lower Peninsula and the Upper Peninsula.

By going to [www.michigan.gov/burnpermit](http://www.michigan.gov/burnpermit), citizens can obtain a burn permit online. Citizens also can call a toll-free number at 866-922-2876 to obtain a burn permit as well. Persons who call the toll-free line will have their permit recorded and they will get a confirmation number. The permit is FREE of charge.
